# **Allyce Twedt Memorial Education Scholarship**

BOMA GLR Annual Scholarship Program
For RPA Or Other BOMI Certificates and Designations
APPLICATION DEADLINE – September 3, 2017

## **Eligibility Requirements:**

In order to be eligible to receive a scholarship, the applicant must meet the following criteria:

- A member in good standing with BOMA GLR (dues, and any other bills paid).
- Demonstrate a continued desire to develop self along a commercial real estate career path.
- Have demonstrated some level of committee and/or event participation with BOMA GLR over the last year.
- Comply with BOMI's eligibility requirements to enter and ultimately achieve the RPA designation or other selected BOMI designation.
- Financial need is not a consideration.

#### **General Information:**

BOMA GLR awards a total of \$1,500.00 in scholarship monies, to be distributed as two (2) separate, individual scholarships of \$750.00 each. The scholarship may be used for BOMI courses offered in the classroom format through BOMA GLR. It may not be used for home study courses, online courses, or facilitated group study. The scholarship award must be used for a BOMA GLR class commencing before September 30<sup>th</sup> of the following year in which it is awarded.

### Applying for the Scholarship and Subsequent Selection:

To be considered for the scholarship, interested applicants must meet the eligibility requirements outlined above and submit in essay or narrative format, not to exceed 750 words, their passion for the profession and mission alignment with BOMA GLR. Final submittal shall also include a recommendation from the applicant's immediate supervisor.

The Chairs of the Education Committee will lead the Selection Panel. The Selected Panel will be made up by the members of the Education Committee. If an Education Committee member wishes to apply for a scholarship, they must recuse themselves from the Selection Panel. After the Education Committee has reviewed all applications submitted by the deadline, a secret ballot will be cast and the two applicants receiving the most votes will be awarded a \$750 scholarship each. Application for the scholarship should be emailed to <a href="mailto:boma@bomaglr.org">boma@bomaglr.org</a> with Scholarship Applicant in the Subject Heading. Applications are due by <a href="mailto:September 3">September 3</a>, 2017 before 5 pm. BOMA GLR will directly disburse the tuition funds to BOMI on behalf of the recipient for enrollment in the class of their choice. Applicants will be notified of the awarding of scholarships by October 4, 2017.

# **Responsibilities of the Recipient:**

- The recipient of the scholarship is responsible for attending all classroom sessions and achieving a passing grade on the course examination. Failure to pass the exam after two (2) unsuccessful attempts shall disqualify candidate from applying for future BOMA GLR Scholarship monies. Failure to pass the exam after three (3) unsuccessful attempts may require the recipient to repay the scholarship funds back to BOMA GLR.
- The recipient is to maintain an active BOMA membership for a minimum of one (1) year upon acceptance of the scholarship and is required to actively participate on a BOMA GLR committee during the course of the following calendar year. Failure to comply with these requirements may require the recipient to repay the scholarship funds back to BOMA GLR.
